

NOTICE OF FORFEITURE PRELIMINARY REVIEW HEARING

If property was seized from you by a law enforcement agency for forfeiture, a Preliminary Review Hearing will be conducted by a judge at 1:30 p.m. at the Richard J. Daley Center, 50 W. Washington, Room 1707, Chicago, Illinois, 60602, to determine whether there is probable cause that the property may be subject to forfeiture. The date of the Preliminary Review hearing is determined by the date of the seizure as shown below. If the judge determines that the property may be subject to forfeiture, the Cook County State's Attorney's Office will send you and any known interest holders a Notice of Pending Forfeiture pursuant to the procedures set forth in the Drug Asset Forfeiture Procedures Act, the Money Laundering Act, or Article 36, 725 ILCS 150, *et seq.*, 720 ILCS 5/29B, *et seq.*, or 725 ILCS 5/36, *et seq.*, respectively.
