- **C.** Never use my sex, sexuality, or sexual activity to induce or persuade any individual to sell or deliver a Controlled Substance, dangerous drug, marijuana, or any other substance purported to be same to any member of the Chicago Police Department, Bureau of Internal Affairs.
- **D.** Never initiate, become involved in an investigation, or gather information on a person(s) or organization(s), solely because of the person(s) or organization(s), First Amendment conduct, or selectively for political, religious, or personal reasons.
- **E.** I further understand that I may never search any suspect, person, house, papers, or personal effects.
- F. I may never become involved in any activities that would constitute entrapment.
- **G.** I further understand that I may not engage in any illegal or improper conduct so long as I am working with the Chicago Police Department, Bureau of Internal Affairs, as a Cooperating Individual.
- **H.** Further, I understand that any violations arising from my actions in violation of the above circumstances will result in an investigation of matters and if the charges are substantiated, appropriate action (including the possibility of criminal prosecution) will be taken.
- I. I am agreeing to function as a Cooperating Individual of the Bureau of Internal Affairs of my own free will and accord, and not as a result of any intimidation or threats.

In agreeing to work as a Cooperating Individual for the Chicago Police Department, Bureau of Internal Affairs, I understand that no Bureau of Internal Affairs police officer may make any explicit or implicit promises or predictions regarding the likely disposition of any criminal proceedings that are pending against me, but the officers of the Chicago Police Department, Bureau of Internal Affairs, will make their best efforts to arrange a meeting with prosecutorial authorities at which time such matters can be discussed.
