**eLearning Module Purpose** eLearning modules will provide the learner with the opportunity to access electronic training materials during all watches using the intranet. When there is a review test that is offered at the end of the module, it will allow the learner to confirm how well they have understood the eLearning material presented in the module.

**Streaming Video Purpose** Streaming videos will provide the learner with the opportunity to access training materials which cover a variety of subject-matters. These subject-matters will encompass topics ranging from Department policies and procedures to legal updates and other special considerations relevant to Department operations.

Both **eLearning modules** and **Streaming Videos** will include goals and/or objectives. A **goal** is a **comprehensive, over-arching purpose**. (Ex. The goal of this instruction is to teach the learner to properly document events that require a case report). An **objective** is an **exact** and **quantifiable** activity that will be used by the learner to accomplish a broader goal (Ex. **Objective one** of this curriculum is to ensure that an officer can identify the six elements of an event, requiring a police report to be properly documented in a case report).

In order to adequately document training, IDQC requests that this form be completed and submitted along with copies of the current instructional materials (lesson plans, Power Point Presentations, videos, hardcopy/electronic handouts, etc.) at least two weeks before the scheduled presentation of the material, if possible.
