<u>Cap, Campaign</u>: Wool/felt, double-brim, four-piece strap, applicable checkerboard band "STRATION" or approved equal.

- \*3. English Riding Wool (see sworn Specification #20.1813 or Breeches #20.1814 for fabric), or approved equal. Straight leg, double seat and inside zippered knees.
- \*4. <u>English Riding</u> Plain toe, inside zipper optional. "Dehner Boots: Boot" or approved equal.



#### SUMMER DRESS AND FIELD - PRESCRIBED ITEMS

Same as the spring/fall dress and field configurations, however, delete cloth jacket, necktie, long sleeve shirt and add short sleeve shirt.

- <u>Traince</u>: See Specification #21.1809, however, trouser items are amended to read: Trouser, "typical" blue jean denims, without designer ornamentation.
- 2. <u>Stable Wear</u>: See sworn Specification #3.1522 (coveralls); or the trainee configuration may be utilized for this function.
- AUTHORIZATIONS/ 1. This specification identifies those uniform items which are RESTRICTIONS: Currently approved and utilized by sworn members assigned to the Mounted Patrol Unit. However, all sworn members of the Department are required to possess "prescribed" dress and field uniform and/or equipment items identified in the related General Order entitled "Uniforms/Citizens Dress and Personal Equipment.
  - 2. Unless otherwise restricted or prohibited by the Commanding Officer of the Mounted Patrol Unit, optional personal equipment items may be utilized as described in related Department directive.
  - 3. Many equipment items are authorized for use by the Mounted Patrol Unit which are Department owned and have been excluded from this Specification. Identification of these items may be directed to the Commanding Officer of the Mounted Patrol Unit or the Director of the Research and Development Division.
