ITEM: TURTLENECK/ TURTLENECK DICKEY - OPTIONAL

The optional turtleneck/ turtleneck dickey shall comply with the construction specification detailed herein, and be manufactured by an approved manufacturer listed under this specification number with an alpha designator (e.g., 9161.1801A).

GENERAL DESIGN: The turtleneck will be a close-fitting pullover style with set in shoulders and attached turtleneck collar and cuffs using one ply of the specified fabric for the body and sleeve and two plies of the specified stretch fabric for the collar and cuffs. Features of design may be uniform jersey hem or rear body panel may extend in a uniform length tail, not to exceed 2.5 inches.

The turtleneck dickey will be a close-fitting pullover style with attached collar using one ply of specified fabric for the body width two plies of the specified stretch fabric for the collar. The collar may optionally be interlined with one ply of fusible stretch interlining.

For crossing guard and all other civilian personnel: The turtleneck /turtleneck dickey will be embroidered on the front center of the turtleneck collar with the City of Chicago Seal centered by the words City Of, to the left and the word Chicago to the right. The city seal will be embroidered in the appropriate colors and the lettering for the City of Chicago will be white in color.

All embroidery will be in bold block font.

COLOR: Dark Navy Blue

MATERIALS:

FABRIC: Body: 100% cotton or cotton Lycra blend not to exceed 90% cotton/ 10% Lycra.

Collar

and Cuffs: Must contain a minimum of 5% to a maximum of 10% Lycra in the knit composition.

Weight: Linear density may range from 5.4 oz. to 7.0 oz per square yard for body construction materials
When combined with collar and cuff construction
Linear density may range from 6 oz. to 10.5 oz per square yard.

Color fastness

and Crocking: Dye methods will be appropriate so as to ensure color retention and minimal crocking. Machine washable and dry cleanable.

INTERLINING: OPTIONAL- Cloth type: 100% polyester stretch fusible.

THREAD: 100% POLYESTER SIZE #70.
Color: Shall match specified fabric

Embroidery Thread: White: Madeira 1002 equivalent to Pantone® 9060C
Gold: Madeira 1069 equivalent to Pantone® 116C

Embroidery: Font: Full Athletic Block 2
Size: 3/4"
Placement: Front center of collar

SPECIFIC CONSTRUCTION:

SEAMS: All turtleneck/turtleneck dickey seams shall be stitched using an overlock machine. The seam attaching the turtleneck to the body and the bottom hem shall be overstitched using a two needle overstitch. All seams shall be straight and clean with thread ends trimmed.

REINFORCEMENT: The shoulders and underarm shall be reinforced with the tape or elastic cord to prevent these seams from coming apart under stress. The tape shall run the entire length of the shoulder seam and be caught in the collar attaching seam and the sleeve setting seam.

SIZE RANGE: Unisex sizing expressed as sizes, available as follows: S(36-38), M(40-42) L(44-46), XL(48-50), XXL(52-54), XXXL(56-58), to fit men and women.

MANUFACTURER'S SPECIFICATION/LABEL:

The turtleneck/turtleneck dickey shall be permanently labeled with the manufacturer's name and size. In addition, a label shall be affixed to the outside collar under the folded crease. This label shall bear the manufacturer's name and Chicago Police Department (or "CPD") approved. No manufacturer or representative may suggest that a garment is an approved Chicago Police Department prescribed garment without prior inspection of a completed sample and written authorization of the Assistant Deputy Superintendent, Research and Development Division, Chicago Police Department.

- AUTHORIZATION:**
1. The turtleneck /turtleneck dickey is classified as an **OPTIONAL** uniform for all sworn members, crossing guards, and all other uniformed civilian personnel.
 2. The turtleneck/turtleneck dickey may only be worn under a long-sleeved uniform shirt and **will not** be worn as an outer garment.
 3. The turtleneck/turtleneck dickey **will not** be worn under a short-sleeved uniform shirt.
 4. A turtleneck/turtleneck dickey **will not** be worn under a sweater as specified in Uniform specification Number 9161.212 without a long-sleeved uniform shirt.
 5. A turtleneck/turtleneck dickey **will not** be worn with any dress (wool) uniform configuration.

RESTRICTIONS: The following restrictions will apply:

1. The turtleneck /turtleneck dickey is an optional uniform item **authorized for field duty only.**
2. The long sleeved uniform shirt will be worn over the turtleneck/ turtleneck dickey with **only** the top button unfastened and no tie.
3. Under no circumstances will the turtleneck/ turtleneck dickey be worn when the temperature is **at or above 70 degrees Fahrenheit.**
4. The turtleneck/turtleneck dickey is authorized as an optional winter uniform garment that may be worn from **01 November through 30 April.**
5. The following out of season provision apply to this item:
 1. At temperatures below 60 degrees, the turtleneck /turtleneck dickey may be worn under the long sleeved uniform shirt, provided the appropriate outer is also worn.

NOTE: The outer garment may be the lined or unlined sweater.
 2. At temperatures below 70 degrees, the turtleneck/turtleneck dickey may be worn when the long sleeved shirt is the outer garment.
